#### ABSTRACT and PAPER PRESENTATION UPLOAD/REVIEW PROCESS

The initial Abstract submission is accomplished using the procedures starting on page #2 of 12 to access the Georgia Tech FDA website at <a href="http://www.ap-concepts.com/2021\_FDA/">http://www.ap-concepts.com/2021\_FDA/</a> by first selecting the {Make Submission} feature shown on the next page where the following specific info must be entered;

- Enter email address
- Select Paper Topic
- Enter Keywords and Abstract
- Select your password
- Enter Optional Comments if needed

Upon completion of the "Make Submission" information, authors will then be provided via an email from Georgia Tech with a **Submission ID** number for future uploads and paper corrections to be used in combination with the author's selected password.

#### PAPER UPLOAD and REVIEW PROCESS

During the week that occurs eight weeks prior to the **26 April 2021** starting date of the FDA Conference, Authors are reminded to upload the preliminary copy of their accepted paper and Microsoft<sup>®</sup> PowerPoint<sup>®</sup> or other TRUC/GaTech conference properly formatted presentation to <u>http://www.ap-concepts.com/2021 FDA/</u>. Both the preliminary and subsequent papers with power point submissions will be reviewed by the assigned Session Chairperson or Vice-Chairperson. You will be notified by your Session Chairperson or Vice-Chair if there are any questions or issues related to your paper and/or power point presentation that require correction, deletion or modification, or if everything submitted is approved.

#### TIME FOR PAPER

The time allocated for each paper at the Conference is stated in the program. It is expected that the oral presentation of the paper be completed 10 minutes prior to the allocated time. The remaining 10-minute period will be used for questions and/or discussions about the paper presentation and the changing of Speakers.

#### AUTHOR'S GUIDELINES FOR FORMAT AND PRESENTATION OF PAPERS

#### CONTENT OF PAPER

The paper should emphasize more of the "why" and/or "how" more than the "what." Tell "why" or "how" a technique or scheme was applied to solve a problem. The paper should contain information of technical significance as opposed to commercial significance. <u>Vendor product</u> <u>names, promotional material and logos within the presentation must be avoided</u> as this has prompted numerous complaints from conference participants during previous conferences.

#### PRESENTATION

It is recommended that your presentation be prepared on a TRUC/GaTech approved Microsoft<sup>®</sup> PowerPoint<sup>®</sup> or other approved TRUC/GaTech formatted document such as a PDF.

Total time limit for each presentation is 40 minutes which includes 10-minutes for Q&A. Since the FDA 2021 conference is virtual, time keeping will be conducted differently. Each speaker will be notified at 25 minutes into their presentation that they have five minutes remaining to conclude their presentation. Either the Hopin Moderator, GaTech technician or Session Chair will advise the Speaker that they are at the five-minute window to wrap up their presentation. There will be no audio available for the conference attendees to ask questions. All questions must be submitted via the Hopin CHAT window. Any 'time' overruns with questioners from the audience should be handled by conversing offline between the audience participants/questioners and the Speaker.

Should there be any last-minute changes to your Microsoft<sup>®</sup> PowerPoint<sup>®</sup> or other approved TRUC/GaTech formatted document presentation prior to your time to speak on Hopin for the FDA conference, please email the new PDF or Microsoft<sup>®</sup> PowerPoint<sup>®</sup> to the GaTech technician so it can be uploaded to the GaTech website for presentation at the proper time.

#### SLIDES AND VISUAL AIDS

For best time management, the presentation should contain no more than 25 slides.

There will be no overhead projection equipment available for this virtual conference. Everything will be presented using the shared screens of GaTech computers.

#### ITEMS TO REMEMBER:

- ✓ Embed true-type fonts in presentation and pdf files.
- ✓ Check videos for clarity and proper color displays if embedded in presentation.
- ✓ No vendor company logos or names within the paper or presentation material except as noted in the following paragraph.

The FDA Conference is a technical forum. Therefore, with the exception of the first cover page of the TRUC/GaTech approved PowerPoint/PDF presentation material that can have one vendor company logo and company name alongside each author, vendor specific promotional data, vendor product names as well as vendor logos must <u>not</u> be included anywhere else in the Microsoft<sup>®</sup> PowerPoint<sup>®</sup> or PDF slides. Utility (non-vendor) users are authorized to include their logos throughout the PowerPoint and PDF presentation slides.

#### AUTHOR'S GUIDELINES FOR FORMAT AND PRESENTATION OF PAPERS

The slides should summarize the content of the paper. The TRUC/GaTech template for the first cover page and other slides must be implemented and can be downloaded at: <a href="https://truc.org/wp-content/uploads/FDA">https://truc.org/wp-content/uploads/FDA</a> 2021-GaTech-First-Page-PPT-1.pptx

It is assumed that a Microsoft<sup>®</sup> PowerPoint<sup>®</sup> or PDF file will be used in your slide presentation.

In preparing your slides; A frequent complaint in the past has concerned <u>busy</u> slides with very small printing and too much data. Therefore, <u>talking</u> slides should have a maximum of four or five lines. Graphs should be confined to a single graph per slide, with adequately sized labels for easy audience viewing.

Authors who are using presentation software for slides should avoid contrasting colors that bleed or blur along the edges when observed from a computer's projection/shared display. The default presentation software color schemes provided in the software package usually provide the best color, clarity and contrast.

Detailed plots and oscillograms generally have greater clarity when slides are made from a copy stand photograph of the printed image rather than the CRT image.

The approved late paper submittal can also be mailed to the address below by the author(s) before the FDA conference commences, but emailing is much faster and the preferred method of communication. 
INSTRUCTIONS FOR PARTICIPATING AS A SPEAKER USING THE HOPIN PLATFORM

All **Speakers** must sign in to Hopin to create an account with your username and password using the following link; <u>https://hopin.com/users/sign\_in</u> **Note:** When you initially sign up for any Hopin event, you will be asked to create a free account. The account allows you to access the event and fill out your attendee profile. If you already have an account, please sign in using your Hopin credentials when prompted to do so.

#### 1.) The Speaker must test their computer's internet Video and Audio capability:

- Google Chrome browser is recommended; Mozilla Firefox will also work properly. Other browsers such as Internet Explorer will not work. Test is designed to check your browser's audio and video compatibility.
- Allow access to your microphone and camera. The results will indicate if your computer passes or not.

# 5.) All FDA 2021 PowerPoints should be sent to GaTech prior to the start of the virtual conference for uploading to the GaTech website:

The present plan is to have a GaTech technician controlling the FDA 2021 presentations to minimize any technical difficulties that might occur during the PDF or PowerPoint presentations. The Speaker must prompt the GaTech technician as to when the presently shown slide for the presentation should be advanced to the next slide after you have finished discussing the present slide.
